There are approximately 440 registered Umpires in the WFNL.</p> <p>The Junior Field Umpire Coach works in conjunction with the Director of Umpiring, Junior Football Operations Manager and other staff to oversee Junior Field Umpire Coaching and Development for the WFNL.</p> <p>The successful applicant is expected to engage in coaching, as well as establish and maintain appropriate Umpire administration and management practices including selection, development, promotion recruitment, and retention of Umpires within the Western Football Netball League.</p>
